

LUCKY PIK Game Show Live! Facebook Streaming Event

Rules

1. **ENTRY PERIOD:**

The **LUCKY PIK Game Show** Live! Facebook Streaming Event Promotion (“the Live Streaming Event”) begins on Thursday, June 26, 2025 at 7:30 PM Eastern Time (EST) and will end on Thursday, June 26, 2025 around 8:00 PM EST (“the Drawing Entry Period”). One (1) Drawing will be conducted after the Drawing Entry Period to select winners from qualified entries. Fifty (50) winners will be selected to receive a \$100 cash prize. The Live Streaming Event is held via a live video broadcast on the **Facebook** platform (“the Platform”) and the winners will be contacted after the Drawing, via the Platform, to confirm eligibility.

2. **ELIGIBILITY:** The Drawing is open to all Georgia residents who are at least eighteen (18) years old or older and have a Facebook account. Selected entrants for prizes must be able to prove residency, age and provide a mailing address. By submitting an entry, Entrant agrees to comply with the Georgia Lottery Facebook Contest Rules at galottery.com/en-us/content/facebook-rules. Entrants do not have to be a Players Club member to win. No purchase is necessary to enter or win. Entrants are subject to all rules and regulations, the drawing procedures and Facebook rules and regulations. This Live Streaming Event and/or any parts thereof, including the award of any prizes, is void where prohibited by law. Employees of the Georgia Lottery Corporation (“GLC” or “Georgia Lottery” or “Sponsor”), Atlas Experiences LLC (“Atlas”), IGT Global Solutions Corporation, BBDO Atlanta, Scientific Games, LLC (“SG”), and their respective parent companies, affiliates, subsidiaries, directors, officers, agents, contractors, advertising/promotional agencies, (collectively, “Sponsors”), and immediate family members living in the same household of each are prohibited from participating in this Live Streaming Event.

3. **HOW TO ENTER:** All entries must be submitted within the Drawing Entry Period for the Drawing. Winners will be randomly selected from the following method of entry: Participants are entered into the Drawing by commenting in the chat window of the Facebook Live broadcast with their “Lucky Pik Number” (one (1) through ten (10)) during the specified Drawing Entry Period. The comment in the chat window must contain a number in either numeric or written form, i.e., ten or 10, to constitute a qualified entry, and deemed, by the Georgia Lottery Corporation, as adhering to the Georgia Lottery Facebook Contest Rules. Any comment containing spam links, offensive language, personal attacks or incessant similar posting will be disqualified from this Live Streaming Event. Only one (1) comment per follower

will be eligible.

Entries sent via any other method, including through any other website submission, social media, U.S. mail/courier, drop-off, etc. will be disqualified.

Entries that do not contain a number in either numeric or written form will be disqualified.

4. **WINNER & PRIZE:** Odds of winning depend on the number of entries received for the Drawing. Entries will be collected via comments in the chat window during the Live Streaming Event for a combined pool of entrants for the drawing. Upon conclusion of the LUCKY PIK Game Show, The Host will reveal the LUCKY PIK Live Number. Participants that selected the LUCKY PIK Live Number will be eligible for the Drawing. Fifty (50) entrants will then be randomly selected to win the cash prize amount of \$100. Prizes are not transferable or assignable.

5. **WINNER NOTIFICATION:** After the drawing is conducted and verified, eligible winners will be announced and tagged in a Facebook post on the Georgia Lottery Facebook page. Winners must private message the Georgia Lottery on Facebook from the winning account in order to confirm their standing as a selected winner. Winners must follow the instructions provided and submit a copy of their Georgia Driver's License, Georgia Identification Card, or other acceptable form of identification, bearing an address within the State of Georgia, as well as a valid email address and phone number. Individuals who fail to provide a valid email address and phone number will not be eligible to win. The following are acceptable forms of identification (bearing a Georgia address):
 - A Georgia Identification card or Driver's License issued by a public agency authorized to issue driver's license in Georgia;
 - An Identification Card issued by any branch of the armed forces of the U.S.;
 - Identification card issued by the U.S. Bureau of Citizenship & Immigration Services;
or
 - Another form of identification authorized for use by a notary public in GA

If selected entrants do not respond to the notification within 15 Days, they will forfeit the prize. Winners of prizes greater than \$600 will also be required to complete, sign, and return a Winner Claim form, Affidavit of Eligibility, and Liability/Publicity Release, and furnish his or her Social Security Number for federal and state tax reporting and withholding purposes within fifteen (15) days of the drawing. If, after reasonable attempts to contact a prize winner by the Georgia Lottery Corporation, a prize winner cannot be contacted or does not return any required form(s) or information within fifteen (15) days of the drawing, the prize may be forfeited. In the event the prize is forfeited, an alternate Entrant will be awarded the prize. Any Prizes valued greater than \$2,500 that are awarded in this Promotion are subject to the debt setoff requirements of the Georgia Lottery for Education Act, O.C.G.A. § 50-27-50 et seq. Upon the satisfactory timely

return of all required forms and verification of eligibility, the GLC shall send payment of all \$100 cash prizes to the mailing address provided by the winners. All drawing entries are subject to verification by the Georgia Lottery or its designee and may be disqualified if eligibility requirements are not met.

If an entrant responds to the Georgia Lottery notification within the specified deadline but fails to provide a valid email address, phone number and acceptable form of identification to the Sponsor, they may be disqualified, and the prize may be awarded to an alternate. Only one prize may be won by a person in the Live Streaming Event Drawing.

6. LIMITATIONS OF LIABILITY: The Georgia Lottery is not responsible for vendor error, interruption, deletion, or delay in operations, technical interruptions, including network, telephone equipment, electronic, computer, hardware, or software malfunctions of any kind, or inaccurate transmission of or failure to receive entry. All entries received will become property of the Georgia Lottery and may be maintained as part of the Facebook Live Streaming Event records. The Georgia Lottery reserves the right to cancel or modify the Live Streaming Event if it becomes technically or otherwise corrupted. The Georgia Lottery reserves the right to disqualify any individual found to be tampering or attempting to tamper with the operation of the Live Streaming Event; to be acting in violation of these Official Rules; to be acting with the intent to disrupt the normal operation of this Live Streaming Event; or to be otherwise acting in an unsportsmanlike manner.
